

## **Terms and Conditions Nocturne Consumer Competition 2023**

1. No purchase is necessary.
2. The promotion is managed by Cellet Marketing and Public Relations Limited, acting as agents for Pure Michigan and Visit Detroit.
3. The competition is for two persons, flights to and from London to Detroit, 5 days accommodation, car hire for the period and selected entry to attractions in the state. The offering will be referred to as the prize.
4. This competition is not open to employees of, or any workforce connected with, Nocturne Live or its associate partners, airline partners or any companies or agencies and families directly connected with the creation and administration of this promotion.
5. Entry is open to all UK residents over 21 due to the hiring of hire cars in the State of Michigan
6. The prize is non-transferable, and no cash alternative is available. The judges' decision is final, and no correspondence will be entered into.
7. Only one entry per household can be accepted.
8. The closing date for the competition will be as determined by the promoters. The judges cannot accept responsibility for late or lost entries. Proof of sending email is not proof of receipt of entry. Entry cannot be accepted if all details are not provided.
9. The prize winner will be drawn at random from those entrants whose entries have reached by the closing date. This date will be determined by the organisers and may be adjusted due to operational or unforeseen circumstances.
10. The winner will be notified as is reasonably practicable with a target period of 28 days of the closing date. If the prize is unclaimed by the initial winner drawn within 90 days, there will be no further prize draws.
11. Any breach of these terms and conditions by an entrant will void their entry. Misrepresentative or fraudulent entries will invalidate an entry.
12. Pure Michigan, Visit Detroit and their agents reserve the right at any time to cancel, modify or supersede the competition (including altering prizes) if, the competition is not capable of being conducted as specified. This condition also applies to circumstances beyond the control of the organisers, or events that make the completion of the prize offering untenable.
13. The winner may be required to participate in publicity accompanying or resulting from this promotion.
14. These terms and conditions shall be governed by the laws of the United Kingdom but specifically England and Wales and subject to the exclusive jurisdiction of the English courts.
15. Air tickets are based on Economy class, round-trip travel to Michigan. Along with other restrictions stated in the airline booking profile, denied Boarding Compensation, Mileage Plus accrual and upgrading are not permitted. Travel is valid only on designated carrier. The air tickets will be issued by the chosen airline and may be in voucher form,

16. Reservations are subject to space availability at the time of booking and are non-changeable once issued. Blackout dates may apply. Flexibility in the time of departure may be required.
17. Ticketing and all travel must be completed within 12 months of the prize being awarded and is not extendible.
18. Accommodation comprises 5 nights' accommodation for 2 persons sharing one room which will be 3\* and above. All dates subject to availability, blackout dates may apply, this will include public holidays in both the US and UK and certain peak travelling times including school holidays. This will be determined solely by the agents of Pure Michigan and Detroit who reserve the right to exercise discretion.
19. Additional meals and refreshments during travel and in country is the sole responsibility of the prizewinner and the organizers will not accept liability for costs beyond flights, accommodation, and car hire.
20. 5 Days Car Hire based on a compact economy car, with standard insurance included, additional cover is **recommended** at the expense of the prizewinner. Petrol for car hire is not included. The cost of the hire car must be paid for by the winner at the time of booking collecting and returning the vehicle who will need a credit card in their name with sufficient funds for this purpose. Following the completion of the trip Pure Michigan and Visit Detroit will reimburse the cost of the hire car not exceeding the limitations of the prize. As car hire will require age limitations the winner must be able to fulfil that criteria and no additional cost will be accepted by the organizers for additional cost of exceptions.
21. Travel insurance is the responsibility of the winner and is a condition of travel. All participants are responsible for their own legal travel documentation including but not limited to valid passports and necessary Visas/ESTA.
22. Transfers, meals, and incidental expenditure are not included and are the responsibility of the winner.
23. The prize is non-changeable, non-transferable and there is no cash alternative.
24. It is the responsibility of the prizewinner to check and comply with visa requirements for entry to the USA and to bear the costs of any visa required. Failure to meet entry requirements of the US will render the prize invalid.
